Customers Enrolled with a Retailer or paying Market Rates also pay the Global Adjustment (monthly rate set by OEB)

NOTE: Residential and Small Commercial customers can choose their price plan anytime, either TOU (Time-of-Use), ULO (Ultra-Low Overnight) or Tiered prices. It is also possible to revert back at any time.

*Effective Nov 1, 2023 RPP Consumers that are not TOU pricing pay prices in two tiers: Residential: Tier 1: First 1,000 kWh @ \$0.103 per kWh; Tier 2: Remainder @ \$0.125 per kWh

Small Commercial: Tier 1: First 750 kWh @ \$0.103 per kWh; Tier 2: Remainder @ \$0.125 per kWh

DRP - Distribution Rate Protection increased from \$38.08/month to \$39.49/month effective July 1, 2023 (Residential customers pay a maximum of \$39.49/month between Distribution and Monthly Service Charge)

Effective Nov 1, 2023, the Ontario Electricity Rebate (OER) will be 19.3% and applies to RE and GS<50kW. Some GS>50KW may be eligible if they meet certain criterias.

Effective January 1, 2020, a consumer who leaves the RPP (aka who chooses to stop purchasing electricity through the Regulated Price Plan) will either pay or receive a "final RPP variance settlement amount" (FSVA)
